Late Pick Up Fee

Children must be dropped off no earlier than 7:00 am and picked up before 6:00pm each day. Failure to do so will result in a \$50 Late Fee, that must be paid before the child can return to the program.

NSF Cheques

There will be a \$50 charge for each NSF cheque that is received. Receiving a 2nd NSF cheque from a family will result in immediate termination from the Before & After School Program. No exceptions.

Tax Receipts

All receipts will be issued in February to the person specified on the Registration Form. Please keep both receipts in a safe place, as only one copy of each receipt will be issued.

Withdrawal from Program

One full calendar month's notice must be given, in writing to the Program Supervisor, to withdraw from the Before & After School Program. Unused post-dated cheques will be destroyed, or returned to the parents, upon receipt of the written notice.

*The MPMAP is closed on all PLC days, school breaks, conventions and statutory holidays.

Ages accepted

This program is available for children attending Meath Park Public School , in grades Kindergarten to grade 6 only. No other ages will be accepted.
